MEETING MINUTES OF THE PRESENTIAL BIDDING SESSION PROCESS No. 67103.220244/2022-43
PRESENTIAL AUCTION No. 01/CABE/2023

<u>Object</u>: Contracting of unaccompanied baggage transportation on behalf of three militaries, in accordance with the conditions, quantities and requirements established in this Bidding Process and its attachments.

On the 20<sup>th</sup> of January 2023 at 12:00 pm, at 16 Great James Street, London, WC 1N 3DP, the Auctioneer Vanessa Erler Martins Lehmann Maj together with the Support Team composed by Mauro Nunes de Souza WO and Patrícia Soares Lustosa 2° Sgt, designated by the Ordinance n° 001, of 13<sup>th</sup> of January 2023, in order to carry out the procedures of the aforementioned Auction Session, in accordance with the Bidding Process and its respective annexes, published on DOU (Official Gazette of Brazil) n° 04 on the 05<sup>th</sup> of January 2023.

- 1. There was no presence of any company.
- 2. The following bidders submitted the documents prior to the public session (by post):
  - 2.1 GERSON RELOCATION LIMITED;
  - 2.2 GRUPO AMYGO:
  - 2.3 ICON MOVING SERVICES LIMITED.
- 3. The envelopes of ICON MOVING and GERSON RELOCATION were opened and the price proposals were initialled by the auctioneer and support team.
- 3.1 The company GRUPO AMYGO did not sealed the envelopes, as required in the item 3.4, b, of the Bidding Process, being disqualified.
- 3.2 Afterwards, the Auctioneer and the Support Team analyzed the adequacy of the proposals to the requirements of the Bidding Process, which were deemed adequate. The following bidders were then classified or disqualified for the price proposal phase:
