**MEETING MINUTES OF THE PRESENTIAL BIDDING SESSION
PROCESS No. 67103.230025/2023-53
PRESENTIAL AUCTION No. 002/CABE/2023**

Object: Contracting of unaccompanied baggage transportation on behalf of six military officers, in accordance with the conditions, quantities and requirements established in this Bidding Process and its attachments.

1. On the 2nd of March 2023 at 12:00 pm, at 16 Great James Street, London, WC 1N 3DP, the Auctioneer Vanessa Eler Martins Lehmann Major together with the Support Team composed by Fernando Levandoski Senior Master Sergeant and Marcos Xavier da Silva Senior Master Sergeant, designated by the Ordinance n^o 01, of 13th of January 2023, in order to carry out the procedures of the aforementioned Auction Session, in accordance with the Bidding Process and its respective annexes, published on DOU (Official Gazette of Brazil) n^o 33 on the 13th of February 2023.

1.1 There was no presence of any company.

2. The following bidders submitted the documents prior to the public session (by post):

- 2.1 GERSON RELOCATION LIMITED;
- 2.2 GRUPO AMYGO;
- 2.3 ICON MOVING SERVICES LIMITED;
- 2.4 CONFIANÇA LOGISTICS LLC; and
- 2.5 GALLEON INTERNATIONAL SHIPPING COMPANY LIMITED.

3. The envelopes of GERSON RELOCATION, GROUP AMYGO, CONFIANÇA, ICON MOVING and GALLEON were opened and the price proposals were initialled by the auctioneer and support team.

3.1 Afterwards, the Auctioneer and the Support Team analysed the adequacy of the proposals to the requirements of the Bidding Process. The following bidders were then qualified or disqualified for the price proposal phase:


4. The Auctioneer and Support Team carried on with analysis of all documents related to the qualification of bidder whose proposals were classified.
