**MEETING MINUTES OF THE PRESENTIAL BIDDING SESSION
PROCESS No. 67103.230152/2023-52
PRESENTIAL AUCTION No. 005/CABE/2023**

Object: Contracting of unaccompanied baggage transportation on behalf of five military officers, in accordance with the conditions, quantities and requirements established in this Bidding Process and its attachments.

1. On the 21st of June 2023 at 12:00 pm, at 16 Great James Street, London, WC 1N 3DP, the Auctioneer Vanessa Erler Martins Lehmann Major together with the Support Team composed by Fernando Levandoski - Senior Master Sergeant and Geraldo de Souza Conceição - Warrant Officer, designated by the Ordinance nº 01, of 13th of January 2023, in order to carry out the procedures of the aforementioned Auction Session, in accordance with the Bidding Process and its respective annexes, published on DOU (Official Gazette of Brazil) nº 108 on the 07st of June 2023.

1.1 There was no presence of any company.

2. The following bidders submitted the documents prior to the public session (by post):

- 2.1 GERSON RELOCATION LIMITED;
- 2.2 GRUPO AMYGO;
- 2.3 ICON MOVING; and
- 2.4 GALLEON INTERNATIONAL SHIPPING COMPANY LIMITED.

3. The envelopes of GERSON RELOCATION, GROUPO AMYGO, ICON MOVING and GALLEON were opened and the price proposals were initialled by the auctioneer and support team.

3.1 Afterwards, the Auctioneer and the Support Team analysed the adequacy of the proposals to the requirements of the Bidding Process. The following bidders were then qualified or disqualified for the price proposal phase:

ITEM 1: Aix- en- Provence – Rio de Janeiro

The company GALLEON presented the incorrect amount for item 3. It was considered the right amount being US\$ 17,356.40 that was the sum of individual itens, according to item 8.5 of the Bidding Process.

The company GRUPO AMYGO presented the incorrect amount for the Total (Maximum allowance volume X Price per cbm) in all 5 items, resulting in the incorrect Total for

Relocation. For this reason the company was disqualified, according to item 7.1 of the Bidding Process.

4. The Auctioneer and Support Team carried on with analysis of all documents related to the qualification of bidder whose proposals were classified.

5. Finally, the following companies were declared qualified, as they met the bidding requirements and presented the best proposals, ranking first in this Bidding Process, according to the table below:
