**MEETING MINUTES OF THE PRESENTIAL BIDDING SESSION
PROCESS No. 67103.230194/2023-93
PRESENTIAL AUCTION No. 006/CABE/2023**

Object: Contracting of unaccompanied baggage transportation on behalf of four military officers, in accordance with the conditions, quantities and requirements established in this Bidding Process and its attachments.

1. On the 24th of August 2023 at 13:00 pm, at 16 Great James Street, London, WC 1N 3DP, the Auctioneer Vanessa Erler Martins Lehmann Major together with the Support Team composed by Marcos Xavier da Silva - Senior Master Sergeant and Elisângela Gonçalves Bastos de Alcantara - Warrant Officer, designated by the Ordinance nº 09/ACI, of 09th of January 2023, and nº 38/ACI, of 03rd of April 2023, in order to carry out the procedures of the aforementioned Auction Session, in accordance with the Bidding Process and its respective annexes, published on DOU (Official Gazette of Brazil) nº 151 on the 09th of August 2023.

1.1 There was no presence of any company.

2. The following bidders submitted the documents prior to the public session (by post):

- 2.1 CONFIANÇA LOGISTICS LLC;
- 2.2 GRUPO AMYGO;
- 2.3 GALLEON INTERNATIONAL SHIPPING COMPANY LIMITED; and
- 2.4 ICON MOVING SERVICES LIMITED.

3. The envelopes of CONFIANÇA LOGISTICS LLC, GROUPO AMYGO, GALLEON INTERNATIONAL and ICON were opened and the price proposals were initialled by the auctioneer and support team.

3.1 Afterwards, the Auctioneer and the Support Team analysed the adequacy of the proposals to the requirements of the Bidding Process. The following bidders were then qualified or disqualified for the price proposal phase:

ITEM 1: Stockholm – Brasília

The company GALLEON did not present price proposal for item 2 above.

The company GALLEON did not present price proposal for item 3 above.

The company GRUPO AMYGO did not present price proposal for item 4 above.

The company GALLEON presented incorrect calculations for the cubic meter total. It was considered the right amount being **US\$ 2,160.00** instead of US\$ 1,944.00, therefore arriving at a total price proposal of **US\$ 12,278.13** instead of US\$ 12,062.13, as per item 8.5 of the Bidding Process.

4. The Auctioneer and Support Team carried on with analysis of all documents related to the qualification of bidder whose proposals were ranked first for each item.

5. The companies AMYGO and GALLEON were considered QUALIFIED by meeting the qualification requirements.

6. After careful analysis of CONFIANÇA LOGISTICS qualification documents, it was considered that the Technical Qualification was not proved. The contract sent was not

signed by the Contracting Party, and does not prove that the company has carried out international removals; therefore being void and not fulfilling item 9.5 of the Bidding Process. Additionally, the Dun&Bradstreet Report issued for this company showed a Risk Indicator 4 (High), which does not comply with the minimum requirements stated at item 9.4 from the Bidding Process and the company was therefore DISQUALIFIED.

7. Finally, the following companies were declared qualified, as they met the bidding requirements and presented the best proposals, ranking first in this Bidding Process, according to the table below:
