MEETING MINUTES OF THE PRESENTIAL BIDDING SESSION PROCESS No. ° 67103.230208/2023-79
PRESENTIAL AUCTION No. 007/CABE/2023

<u>Object</u>: Contracting the most advantageous proposal for the most advantageous proposal for the provider of continuous cleaning and conservation service for CABE's internal and external areas, in accordance to the conditions, quantities and requirements established in the Bidding Process above mentioned and its attachments.

- 1. On the 21<sup>th</sup> of September 2023 at 13:00pm, at 16 Great James Street, London, WC 1N 3DP, the Auctioneer Vanessa Erler Martins Lehmann Lt Colonel together with the Support Team composed by Antonio Carlos Mendonça Senior Master Sergeant and Geraldo de Souza Conceição Warrant Officer, designated by the Ordinance nº 01, of 13<sup>th</sup> of January 2023, Ordinance nº 07, of 14<sup>th</sup> April 2023, and Ordinance nº 12, of 30<sup>th</sup> June 2023 in order to carry out the procedures of the aforementioned Auction Session, in accordance with the Bidding Process and its respective annexes, published on DOU (Official Gazette of Brazil) nº 171 on the 06<sup>th</sup> of September 2023.
- 1. Initially, for accreditation purposes, the participating legal entity was identified, as well as their respective legal representative, according to the established in item 3. of the Bidding Process.
- 2. The Auctioneer asked the accredited to present the declaration of full compliance with the qualification requirements (Annex V), as well as to deliver to the Support Team, envelopes no 01, containing the qualification and no 02, containing the Price Proposal.

- 2.1. The following bidders submitted the documents prior to the public session:
  - 2.1.1 One World Agents Limited;
  - 2.1.2 Hawkey Cleaning & Support Services;
- 3. After the accreditation phase, the envelopes of One World Agents Limited and Hawkey Cleaning & Support Services were opened and the price proposals were initialled by the auctioneer and support team.



3.1 Afterwards, the Auctioneer and the Support Team analysed the adequacy of the price proposal to the requirements of the Bidding Process. The following bidders were then qualified for the bidding phase:

The company Hawkey Cleaning presented incorrect calculations for the total. It was considered the right amount being <u>GBP 32,364.36</u> instead of GBP 32,364.38, as per item 8.5 of the Bidding Process.

- 4. The bidding proceeded, inviting the present bidder to present her verbal bids. The company One World declined the offer to bid verbally.
- 5. The Auctioneer and Support Team carried on with analysis of all documents related to the qualification of bidder whose proposal ranked first.
- 6. The company One World Agents Limited was considered QUALIFIED by meeting the qualification requirements.
- 7. As there was no intention to appeal and without further consideration, the Session was closed at 13:30pm by the Auctioneer, and these minutes were written and after being read, understood and agreed with, have been signed by all present.
