**MEETING MINUTES OF THE PRESENTIAL BIDDING SESSION

**Object:** Contracting of unaccompanied baggage transportation on behalf of four militaries, in accordance with the conditions, quantities and requirements established in this Bidding Process and its attachments.

On the 13<sup>th</sup> of September 2022 at 12:00 pm, at 16 Great James Street, London, WC 1N 3DP, the Auctioneer Leticia Mota de Souza Lt Col together with the Support Team composed by Mauro Nunes de Souza WO and Paulo Cezar Ferreira WO, designated by the Ordinance / Internal Bulletin nº 12, of 15<sup>th</sup> June 22, in order to carry out the procedures of the aforementioned Auction Session, in accordance with the Bidding Process and its respective annexes, published on 30<sup>th</sup> of August 2022.


4. Carried on analysis of all documents related to the qualification of bidders whose proposals were the best classified.


6. The Auctioneer awarded the objects of the auction to the winners of the bidding.
