**Object:** The object of this Bidding Process is international door-to-door removal service from Linköping (Sweden) to Brasília (Brazil) and from London (UK) to São Paulo (Brazil).

**ITEM 1: Linköping (Sweden) – Brasília (Brazil)**

**ITEM 2: London (UK) – São Paulo (Brazil)**
