**Object:** The object of this Bidding Process is international door-to-door baggage transportation services for the Aeronautical Command military personnel and civil servants on mission in Sweden (Linpoking and Stockholm) at their return to Brazil.

The following bidder submitted the new price proposal to the public session (by post):

1. GERSON RELOCATION

The bidders GRUPO AMYGO S.A and ICON MOVING sent an e-mail with the following information:

GRUPO AMYGO S.A: "Due crazy evolution of international maritime transport cost we can't assure freight rates for maritime shipments matching prices and conditions your bidding demand."

ICON MOVING: "Unfortunately we give live rates, from our supply chain in the market, so the costs obtained are both current and accurate. At this present time as you may be aware freight rates are at an all-time high, so with this in mind, I am sorry but we would not be able to offer an alternative bid for the costs required at this time."

**III – FINAL CONSIDERATIONS:**

Considering that it will not be possible to reach the minimum of 3 (three) valid proposals, according to item 8.7 of the Bidding Process, given the participation of only one company, the Bidding Process will be republished.
