MEETING MINUTES OF THE PRESENTIAL BIDDING SESSION PROCESS No. 67103.220197/2022-38
PRESENTIAL AUCTION No. 16/CABE/2022

<u>Object</u>: Contracting of unaccompanied baggage transportation on behalf of one military, in accordance with the conditions, quantities and requirements established in this Bidding Process and its attachments.

On the 06th of December 2022 at 12:00 pm, at 16 Great James Street, London, WC 1N 3DP, the Auctioneer Mariana Sakate Abe Lt Col together with the Support Team composed by Mauro Nunes de Souza WO and Paulo Cezar Ferreira WO, designated by the Ordinance nº 93/SC, of 22nd of November 2022, in order to carry out the procedures of the aforementioned Auction Session, in accordance with the Bidding Process and its respective annexes, published on 18th of November 2022.

- 3.1 Afterwards, the Auctioneer and the Support Team analyzed the adequacy of the proposals to the requirements of the Bidding Process, which were deemed adequate. The following bidders were then classified or disqualified for the qualification phase:

The Company GRUPO AMYGO S.A presented the incorrect total amount for the item London (UK) – Rio de Janeiro. It was considered the correct amount being USD 13,396.00, that was the sum of the individual items.

The Company GERSON RELOCATION was disqualified for presenting the incorrect price proposal (wrong destiny, route and maximum allowance volume).

- 4. Carried on analysis of all documents related to the qualification of the bidder whose proposal was the best classified.
- 5. Finally, the following company was declared qualified, as it met the bidding requirements and presented the best proposal, ranking first in this Bidding Process:
