**MEETING MINUTES OF THE PRESENTIAL BIDDING SESSION
PROCESS No. 67103.220244/2022-43
PRESENTIAL AUCTION No. 17/CABE/2022**

Object: Contracting of unaccompanied baggage transportation on behalf of two militarys, in accordance with the conditions, quantities and requirements established in this Bidding Process and its attachments.

On the 13th of December 2022 at 12:00 pm, at 16 Great James Street, London, WC 1N 3DP, the Auctioneer Leticia Mota de Souza Lt Col together with the Support Team composed by Antonio Carlos Mendonça Sgt and Marcos Xavier da Silva Sgt, designated by the Ordinance nº 93/SC, of 22nd of November 2022, in order to carry out the procedures of the aforementioned Auction Session, in accordance with the Bidding Process and its respective annexes, published on 29th of November 2022.

1. There was no presence of any company.
2. The following bidders submitted the documents prior to the public session (by post):

2.1 GERSON RELOCATION LIMITED;
2.2 CONFIANÇA LOGISTICS LLC.

3. The envelopes were opened and the price proposals were initialled by the auctioneer and support team.

3.1 Afterwards, the Auctioneer and the Support Team analyzed the adequacy of the proposals to the requirements of the Bidding Process, which were deemed adequate. The following bidders were then classified or disqualified for the qualification phase:

ITEM 1: Turim – São Paulo

The Company CONFIANÇA LOGISTICS LLC presented the incorrect total amount for the item Pretoria – Brasília. It was considered the correct amount being USD 23,127.56, that was the sum of the individual items.

Furthermore, the company presented the final price higher than the maximum fixed price of US\$ 18,937.70 established in item 8.7.4 of the Bidding Process and item 1.1 of the Reference Term. Also the company did not sign the price proposal, what leads to the disqualification according to items 5.1 and 8.7.1 of the Bidding Process.

Furthermore, the company also did not sign the price proposal, what leads to the disqualification according to items 5.1 and 8.7.1 of the Bidding Process.

ITEM 7: New Deli – Natal

Furthermore, the company also did not sign the price proposal, what leads to the disqualification according to items 5.1 and 8.7.1 of the Bidding Process.

4. Carried on analysis of all documents related to the qualification of bidder whose proposals were classified.

5. Finally, the following company was declared qualified, as it met the bidding requirements and presented the best proposal, ranking first in this Bidding Process:

6. The Auctioneer awarded the objects of the auction to the winner of the bidding.


